- **Harley T. Davis, MSPH, PhD**

Dr. Davis is currently the director of the Division of Population Health Surveillance at the South Carolina Department of Health and Environmental Control, where she manages multiple population-based surveillance programs. She completed her MSPH in environmental health sciences and Ph.D. in epidemiology at the University of South Carolina.

- **Ciaran Fairman, Ph.D., CSCS, CET**

Dr. Fairman's primary research focus is examining the impact of exercise, nutrition, and supplementation interventions during and after cancer treatments. The purpose of this research is to see if we can prevent or reduce the side effects experienced with cancer and its treatments. Specific research areas include the manipulation of dose, frequency, volume, or intensity of exercise to optimize clinically relevant outcomes in cancer patients; resistance training across the cancer continuum; nutrition/supplementation to augment training adaptations; exercise medicine and tumor biology. Dr. Fairman is also a strong advocate of the dissemination/translation of scientific research to a variety of audiences. He is the host of the REACH podcast (<https://reach.fireside.fm/>), where he discusses the latest research in exercise oncology.
